



DealBlip Consignment Agreement

1. Services: By signing this Agreement, the Consignor agrees to grant DealBlip, Inc. the exclusive right to receive, store and sell on eBay, Etsy or Poshmark the Consignors Goods/Item(s) referencing the above stated Agreement Number.

2. Binding: Once the item(s) are listed, they will run the full course (60 days) until sold. The Seller and Consignor may not withdraw the item(s) after they are sold under any circumstances as they obligated to complete the transaction upon a successful sale, unless the Buyer fails to pay for the item(s). Neither Consignor, its principal, if any, nor any other representative or agent shall bid on the property in the event of an auction. Such bidding is considered shill bidding and is strictly prohibited by DealBlip, Inc. and eBay.

3. Loss/Damage: If at any time the item(s) are lost, damaged, stolen while in the possession of DealBlip, Inc. the Consignor will be reimbursed by the confirmed sale price of the item, or 90% of the last known listing price.

4. Commission and Fees: The Consignor will be entitled to **60%** of the final sale price. DealBlip, Inc. will be entitled to **40%** of the final sale price. This commission is inclusive of all eBay, PayPal, Etsy, Poshmark, USPS, FedEx fees which are solely the responsibility of DealBlip, Inc.

5. Accounting: DealBlip shall provide the Consignor with all accounting records pertaining to Consignors account at the Consignors request. DealBlip shall maintain accurate books and documentation with respect to all transactions entered into on behalf of the Consignor.

6. Unsold Goods: Should the goods fail to sell within 60 days of being listed online the Consignor has the option to:

*1: Agree to allow the items to be relisted for an additional duration of 60 days up to 2 times.

*2: Pick up the item(s) within 14 days from the confirmed notice date.

*3: Request the return of unsold items. The cost of return shipping will be paid by Consignor.

*Note: Any unclaimed items will become property of DealBlip Inc.

(Please refer to the Addendum for further details)

7. Payments:

Once the sale is completed and payment is received, the items will be shipped to the purchaser within 1 business day. Upon safe receipt and acceptance of the items by the purchaser, DealBlip, Inc. will pay the Consignor 60% of the gross proceeds received and collected from the sale of the item. All mailed payments will be sent to the name and address that is printed below on this contract.

Consignor prefers to be paid through Venmo, PayPal or Chase Quick Pay Consignor prefers to be paid by check

8. Local Pick-Ups: A pick-up by DealBlip, Inc. of merchandise in the Queens/Nassau County area is free. There will be a \$20 charge per pickup for Manhattan, Brooklyn or Suffolk County.

9. Seller's Warranty of Goods:

Consignor warrants that he/she is the legal owner of the Goods to be sold and that the Goods are not counterfeit or stolen. DealBlip Inc. holds the right to deny any item. If at any time the Consignors items listed/sold have been proven to be counterfeit, DealBlip reserves the right to deny payment to the Consignor.

Both parties agree that any disputes arising under this agreement will be settled by binding arbitration according to the rules of the American Arbitration Association.

Both parties have read and understand all statements included in this agreement and addendum. This signed agreement and addendum may not be revised or amended without the written consent of both the Consignor and DealBlip, Inc.

DealBlip Consignment Agreement Addendum

***1:** This will give DealBlip, Inc. 6 months to sell the item(s). If the item(s) does not sell the Consignor has the right to reclaim the item(s).

***2:** If at any time the Consignor wishes to reclaim unsold item(s) from DealBlip, Inc. the Consignor will notify DealBlip, Inc. in writing. The Consignor will then have 14 days from the notice date to collect the item(s). The 14 day period begins on the day both parties confirm receipt of the request to claim back the item(s).

***3:** If at any time the Consignor wishes to have the item(s) shipped back to them, an agreed upon cost of return shipping will be paid by Consignor.

***Note:** If the item(s) go unclaimed after the 14 day period, the item(s) become the property of DealBlip, Inc.
